Issuance of shares

Gasol announces that on 30 June 2009 7,042,254 ordinary shares in the Company ("New Ordinary Shares") were allotted, subject to listing, to African Gas Development Corporation Limited ("AfGas") in respect to the funding announced 27 May 2009. Application has been made for the New Ordinary Shares to be admitted to trading on AIM which is expected to take effect on 6 July 2009.

Following admission to trading of the New Ordinary Shares, the Company's issued share capital will comprise 1,055,518,938 ordinary shares, which figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or change to their interest in Gasol under the FSA's Disclosure and Transparency Rules. The New Ordinary Shares will rank *pari passu* with the existing Ordinary Shares.
